### **PUC Opens Docket and Invites Public Comment on The Hawaiian Electric Companies' Grid Modernization Strategy**

HONOLULU – After receiving input from stakeholders and the public, the HECO Companies filed their Final Grid Modernization Strategy with the Commission on August 29, 2017. The Commission has opened Docket No. 2017-0226 to serve as a repository for the HECO Companies' Final Grid Modernization Strategy and any comments from the public.

The Hawaii Public Utilities Commission ("Commission") invites all interested parties to submit public comments regarding the Hawaiian Electric Companies' Final Grid Modernization Strategy. The HECO Companies (Hawaiian Electric Co., Inc., Maui Electric Co. Ltd., and Hawaii Electric Light Co., Inc.) serve the islands of Hawaii, Lanai, Maui, Molokai, and Oahu.

In January 2017, the Commission directed the HECO Companies to develop a Grid Modernization Strategy to provide context and support for future grid modernization projects proposed by the HECO Companies. The HECO Companies submitted an initial draft Grid Modernization Strategy on June 30, 2017.

Modernization of Hawaii's electric power systems, which will include the deployment of technologies such as grid management systems, communication infrastructure, sensors, and automated controls, is fundamental to integrating renewable energy and achieving the state's energy goals.
