SCHEDULE TOU-G

SMALL COMMERCIAL TIME-OF-USE SERVICE

AVAILABILITY:

Applicable to general light and/or power loads less than or equal to 5,000 kilowatthours per month, and less than or equal to 25 kilowatts, and supplied and metered at a single voltage and delivery point. Customers served under this Schedule who exceed 5,000 kilowatthours per month or 25 kilowatts of demand three times in a twelve month period must transfer to Schedule TOU-J or terminate TOU-G service at the beginning of the next billing period.

TIME-OF-DAY RATING PERIODS:

The time-of-use rating periods shall be as follows:

On-Peak:	5:00 p.m. - 10:00 p.m., Daily
Mid-Day:	9:00 a.m. - 5:00 p.m., Daily
Off-Peak:	10:00 p.m. - 9:00 a.m., Daily

RATES:

CUSTOMER CHARGE:

Single-Phase Service - per month	\$31.00/month
Three-Phase Service - per month	\$49.00/month

NON-FUEL ENERGY CHARGE: (To be added to Customer Charge)

On-Peak Period	- per kWhr	19.2942 ¢/kWhr
Mid-Day Period	- per kWhr	9.2942 ¢/kWhr
Off-Peak Period	- per kWhr	16.7942 ¢/kWhr

MINIMUM CHARGE:

Single-Phase Service - per month	\$50.00/month
Three-Phase Service - per month	\$68.00/month

DETERMINATION OF TIME-OF-USE ENERGY:

The Company shall install, own, operate and maintain a time-of-use meter to measure the customer's kWh energy consumption during the time-of-use rating periods.
